Jakob explained the Conservation Committee's concern about Ontario's proposal to reduce the hunting season, rather than end the hunt for this threatened species. The Board encourages members to submit a comment to EBR 012-9170.

5) Committee Reports

- a) Awards Eleanor Zurbrigg
 Eleanor distributed the citations for comment and approval by January 20.
- b) Birds no representative As requested at the ABM, Directors discussed how we might help restore a publicly available weekly birding report, similar to Bruce Dilabio's former column in the Ottawa Citizen. We like how that newspaper column reached a large audience of non-members, stimulated interest in birds, and frequently promoted OFNC events. Gord Robertson (maybe along with Dan Brunton) will ask Bruce for his thoughts on ways of continuing his column.

Rémy noted that SafeWings may have an event at City Hall on Feb 27, the same day as the Board meeting. Also, he heard from Innis Point and Duck Club friends that birders at Shirley's Bay may need to visit the range control office before going on the causeway. He will contact Chris Traynor who signed the MOU on behalf of the Club, to determine if this is the case.

- c) Events Jakob Mueller
 Rob Alvo will speak at the April 11 meeting about his birding trips to Gambia and South Africa.
- d) FWG Ted Farnworth
 Gord is stocking the two feeders. Budd Gardens in Orleans is growing up the native plants to revegetate the slopes around the pond next summer. Diane will request AAFC's help with a watering system, logs and rocks. Gord is designing a bird blind to construct near the pond.
- e) Publications Jeff Saarela The committee received 4 applications for Research Grants this year. They are discussing ideas to recognize great Canadian naturalists.
- f) Ontario Nature Gord Robertson Gord relayed a request that OFNC support Ontario Nature in responding to an Ontario government discussion paper about how forests, in their ability to sequester and store carbon, should be managed to mitigate climate change. Directors felt the timeframe for response was too short.
