6. Nature Canada and the BirdLife World Congress 2013 to be held in Ottawa

lan, as the Executive Director of Nature Canada, gave an overview of what the BirdLife World Congress will be like and asked if the OFNC could provide volunteers. This Congress is not open to the public and is by invitation only.

The official opening will be on the night of June 19 and the Congress will run until the 22nd; there will be 3 days of internal strategic planning on June 17-19.

lan explained that Eagle Eye Tours will be handling post-Congress excursions and that they hoped that the OFNC could provide leaders for local, early morning trips involving one or two bus loads of registrants. Help might also be needed at the Congress Centre throughout the event. Council added that the Club des ornithologues de l'Outaouais should be involved as well. Fenja indicated that in recognition for their support, the volunteers should be allowed to attend some sessions of the congress for free.

The OFNC is also invited to set up booths at the Congress; Council suggested having booths on the Club, on FalconWatch and on the CFN.

ACTIONS:

- a. Ian to send the brochure of the BirdLife World Congress in PDF format to Council members.
- b. Ian to write a proposal describing the needs for volunteers and send to Fenja; Fenja to forward proposal to the appropriate people.
- c. The selected group should meet to start planning the details.

7. Conservation Committee O. Clarkin

Owen said that the committee has been quite busy; he wished to report on these 2 points to Council:

- **a.** House Cats: As there is more and more media and public attention on free-roaming house (and feral) cats and the number of birds and small mammals they kill, the Conservation Committee is advising Council to decide on a position towards this issue.
 - **ACTION:** Owen to present the recommendation of the Conservation Committee to Council in February.
- b. Expansion of Dam on the Mississippi in Almonte: Ian Whyte had suggested that the OFNC should send an opinion letter as this expansion proposal may affect the Appleton Wetland ANSI, the rare Rapids Clubtail dragonfly and the American Eel. Council agreed.

ACTION: Owen to draft the letter on behalf of the OFNC, send to Fenja for her stamp of approval, and to Council for information.
